

# **SNO-BARON'S KIDS SNOWMOBILE/ATV GIVE AWAY OFFICIAL SWEEPSTAKES RULES**

**NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING THE SWEEPSTAKES.**

## **GENERAL**

The Sno-Baron's Kids Snowmobile/ATV Give Away ("Sweepstakes") is a sweepstakes in where four (4) eligible entrants will win one (1) of four (4) prizes to be awarded in this Sweepstakes as described below. When entering the Sweepstakes, an eligible entrant will have the opportunity to enter his or her entry with respect to the four (4) prizes to be awarded in this Sweepstakes as described below. The foregoing is a general description of this Sweepstakes which are governed in its entirety by these official rules ("Kids Official Rules"). This Sweepstakes is sponsored by Sno-Baron's Snowmobile Club, Inc. ("Sponsor"). By participating in the Sweepstakes, each entrant agrees to abide by these Kids Official Rules, including all eligibility requirements, and understands that the results of the sweepstakes, as determined by Sponsor and its agents, are final in all respects. Sweepstakes are subject to all federal, state and local laws and regulations and are void where prohibited by law.

## **ELIGIBILITY**

Sweepstakes are open to legal residents of the United States of America who are between five (5) years of age and twelve (12) years of age ("Entrant"). An Entrant must also have a legal residents of the United States of America who has reached the age of majority in their state of residence ("Guardian") and who has a valid United States mailing address, a valid e-mail account, and a telephone number prior to the beginning of the Entry Period (as defined below). Sponsor has the right to verify the eligibility of each entrant. Members of the Sno-Baron's and their immediate family members (spouse, parent, child, sibling or spouse of each) or those living in the same household of a member are not eligible. Contract Clubs working the Event under contract with the Sno Barons, Sponsors and Vendor employees and not eligible. The sweepstakes is void outside of the United States of America and otherwise where prohibited. **DO NOT ENTER IF YOU DO NOT MEET THE ELIGIBILITY REQUIREMENTS OR DO NOT AGREE TO THESE OFFICIAL RULES.**

## **ENTRY PERIOD**

The Sweepstakes entry period begins at 8:00 a.m. on September 7, 2019 and ends at 2:00 p.m. on September 8, 2019 (the "Entry Period"). All entries must be received during the Entry Period. Sponsor reserves the right to extend or shorten the Entry Period at its sole discretion.

## **HOW TO ENTER**

To enter this Sweepstakes, during the Entry Period, complete an entry form in its entirety and place it into a designated box located at the Sweepstakes Registration Booth located at space ADO on the map behind Ski Doo and Yamaha. Entry forms can be obtained at either 1) the gate ticket booths when coming into Haydays at the North, East, or West gates, 2) Sweepstakes Registration Tables set up outside East or North gates for Entrants not planning to enter Hay

Days, placing your entry in the bucket provided there, 3) Inside Haydays, at the Sweepstakes Registration Booth where you can place your entry form in the bucket provided at the Sweepstakes Registration Booth. For Entrants not planning to enter Hay Days, place your entry form in the bucket provided at the Registration Booth. All fields in the entry form must be completed in order to be considered valid. This includes first and last name, complete mailing address, telephone number, e-mail address, and a completed questionnaire.

Entries shall be limited to one (1) per person. Entries in excess of the one entry allowed may be cause for disqualification. Each Entrant is eligible to win only one prize. All entries become the property of the Sno-Baron's. ### **WINNER SELECTION**

All eligible entries received during the Entry Period will be combined into a large rotating hopper and drawn at random by a member of the Sno-Baron's at the end of the Entry Period. The winners will be drawn on September 8, 2019 at 2:00 p.m. at the Registration Booth. The first entry drawn will win Prize 1 identified below; the second entry drawn will win Prize 2 identified below; the third entry drawn will win Prize 3 identified below; and the fourth entry drawn will win Prize 4 below. Announcement and instructions for each prize will be done live at Hay Days and, if necessary, sent to the e-mail address and telephone number supplied on the potential prize winner's entry form. Entrants and Guardians do not need to be present to win. Each entrant is responsible for monitoring his/her e-mail account and telephone number for prize notification and receipt or other communications related to the sweepstakes. If a potential prize winner cannot be reached by Administrator (or Sponsor) within twenty (20) days, using the contact information provided at the time of entry, or if the prize is returned as undeliverable for any reason, that potential prize winner shall forfeit the prize. Ten (10) alternate winners will be drawn immediately after the final winner is drawn and will only be used if a winner cannot be found or contacted within the twenty (20) day time frame. If a winner cannot be found or contacted, an alternate winner shall be identified in the order they were selected.

Subject to the terms and conditions of these Official Rules, the Sno-Baron's will conduct a total of one (1) drawing in this Sweepstakes. The drawing consists of selecting four (4) eligible Entrants and is limited to the four (4) prizes as described below. The Actual Retail Value of the four (4) prizes to be awarded in the Sweepstakes is \$12,498.00. The odds of winning a prize is directly dependent on the amount of eligible entries received during the Entry Period.
